D/Cllr D Waldron informed the Parish Council regarding the West Suffolk Local Preferred Options Consultation which took place on the 17th May 2022. The West Suffolk Local Plan will cover the period up to 2040. Upon adoption it will set out the Council's policies to address housing and employment needs and other associated economic, social, and environmental priorities.

- (b) Sqn Ldr Andy Bell assumed responsibility as RAF Commander for RAF Mildenhall on 21st April 2022. He reported as follows:
 - a. The airfield will be closed 11pm 26th May to 6am 31st May and 11pm 16th June to 6am 21st June.
 - b. No sorties are currently planned over the Jubilee Bank Holiday.
 - RAF Mildenhall continues to be busy contributing to multiple operations and training exercises.

General update on SCC development plans. Cllr M Peachey has spoken with SCC Highways, and they are still working out how to make a tarmac link between Chapel Road and Cricks Road. The latest proposal is that they would tarmac the existing footpath from Chapel Road (the one that comes out at the Cricks Road/Chapel Road junction), but instead of it coming out where it currently does, which is too narrow, they would make a new route going behind the homes on the north side of Cricks Road before joining with the road further along. Cllr M Peachey has been advised that SCC Highways are running behind and hope to have a full update for us soon.

The Cemetery consultant is still awaiting a reply to the ground test results by the Environment Agency.

13. Matters Relating to Street Furniture/Amenity Provision

- (a) Update on Bench at end of Chairfen Drove The oak barrier to the bench at Chairfen Drove has been installed – Closed.
- (b) Update on Footpaths/Bridleway Projects Cllr M Peachey spoke with SCC about Friday Street Playing Fields footpath, and a new way forward has been found whereby we can now accept the offer by the landowner to dedicate 1.2m of the track width as a public footpath. Such an agreement creates no liabilities or commitments to the Parish Council. The Parish Council APPROVED AND AGREED to accept the offer so that SCC can add it to the definitive map. The public right of way along the track to the Playing Field would be protected in case any further developer or landowner tried to stop people using it.

- (c) Report on Speed Indicator Device Findings No increase or reduction in speeds. Mildenhall Road and Hurdle Drove still have the highest speeds. The pole for the SID has been installed on Pott Hall Road. Clir A Goodenough agreed to support Clir A Fisher with installation of the new SID's. It was APPROVED AND AGREED that Cllr A Fisher can go ahead with a new laptop for the SID equipment.
- (d) Update on Litter and Waste Bin Relocations Nothing to report.
- (e) Update on Community Woodland and Tree Warden Closed.
- (f) Update on Cycle Hoops for Village Shop Planning application has been submitted to WSC and we are awaiting a response.
- (g) Update on Footpath 30 along river at bottom of The Gravel Update next month.
- (h) Update on repair to Pott Hall Road Clerk to contact Highways.
- (i) Update on Footpath/Streetlighting for Crick Road into Church Road New street lighting is now in place and UKPN are scheduled to connect during the first half of June. The pavement connection remains work in progress. Defer to next month.
- (j) Update on post for SID on Pott Hall Road Post has now been installed and Clir A Fisher will now install new equipment. Cllr A Fisher in the process of having the post for SID moved slightly back from the road in Ferry Lane. Defer to next month.

- (b) Update on Coat of Arms No update. Defer until next month.
- (c) Update on the Article for the Echo to explain the remit of the Parish Council and what services West Suffolk District Council and Suffolk County Council are responsible for. Cllr A Fisher has an updated article which will go into the next edition of the Echo and published onto the Parish Council website.
- (d) Update on Tree Preservation Order for the walnut trees down Chapel Road Closed.

Neighbourhood Plan - Grant has been submitted for the Locality Neighbourhood Plan as well as an application for the free Technical Support packages. Fee Proposal from Ian Poole of Places4People has been received. The postcards have been printed for the drop-in event at the Village Hall on the 29th June. We now need to arrange for these to be distributed to each household in the village during the week of 20th June. Cllr T Gooch-Taylor-Balls to ask Lynn Morley about a list of distributors for distributing the postcards, and Cllr T Gooch-Taylor-Balls to write an article to be publish in the Echo.

15. Inappropriate Parking

- (a) Clerk wrote to RAF Mildenhall and has been advised by the Community Relations Adviser that our concerns have been passed onto the Wing Safety office for them to pass onto their airmen. They advise that each Airman, upon arrival in the UK, is given a comprehensive immersion on UK driving standards.
